### SAF Sudan Air forces Ariel Bombing on Hadra village Dalami Locaoty (Nuba Mountains) South Kordofan State

On Thursday, March 14th, 2024, morning at 7:40 AM, (Anitove Bomber) belonging Sudan Armed Forces (SAF) Airforce, indiscriminately dropped bombs on the village of Hadra in Dalami locality- (Nuba Mountains,) South Kordofan state hitting school, Killing 11 children and 2 Teachers and injuring. The indiscriminate targeting of civilian without accurate precision put lives of civilian under great risk at that represent clear failure of Sudan armed forces to adhere to their obligations under Geneva conventions 1949 and its four protocols the perpetrators of such hence crimes must be held to account, the victims included two 3 years children. The victims are:

### Justice Africa Sudan

- Strongly condemn in stronger terms the killing of civilian and demand the establishment of independent investigation and to bring the perpetrators to accounts.
- We remind the warring faction to ensure protection of civilian according to their commitments under Geneva Conventions 1949 and its four protocols,
- We ask for immediate secession of hostilities and opening the corridors for humanitarian assistance.

Almost all the districts of the Nuba mountains are under siege since the start of the ongoing war on the 15<sup>th</sup> April 2024, with the Rapid Support Forces (RSF) and its Allied Militias blocking the main road between North Kordofan and South Kordofan states , preventing the movement of people and goods to the these areas , at the same time Sudan People Liberation Army- North (SPLA-N) blocking the road between El Diliinj and Kadogli ( South Kordofan state Capital ) and that has very serious impacts on the cost of living as the cost of a sack of sorghum triple reaching SDG 100,000 in Kadogli and a famine is looming .

- We urge RSF and SPLM-A to immediately end the blockage of the roads and to ensure safe passage of good and humanitarian assistance.
